### **Governor Riley Appoints New Commissioner To Alabama Securities Commission**

MONTGOMERY, ALABAMA (October 23, 2009) Honorable James L. Hart of Vestavia Hills, Alabama has been appointed as a new Commissioner to the Alabama Securities Commission (ASC) and will assume duties upon confirmation by the Alabama Senate when the Legislature convenes early next year. Joseph P. Borg, Director of the Alabama Securities Commission, said, "Jim Hart's extensive experience in forensic accounting and litigation services will enhance the excellent reputation of ASC as one of the most effective state securities regulatory agencies in the United States."

Hart recently celebrated his 36th anniversary with Dent, Baker & Company, having joined the firm in 1973. Mr. Hart has led the firm in a number of areas during his career and has continuously served as the firm's forensic accounting and litigation services partner for over 30 years. Hart holds the unique distinction of being a past recipient of the Gold Medal Award, which recognizes the highest score in Alabama on the CPA exam.

He is a member of the Alabama Society of Certified Public Accountants (ASCPA), having served in a variety of offices and leadership positions, including terms on the CPA Society's governing board, as well as a term as president of its Birmingham chapter.
